

2021 CHURCH COUNCIL MINUTES FRIEDLAND MORAVIAN CHURCH NOVEMBER 14,2021

The Friedland Moravian Church Council met on Sunday, November 14, 2021 in the Fellowship Hall following a pot luck lunch. The meeting was called to order at 1:14pm and opened with prayer by the Rev. John Rights. There were 66 voting members in attendance.

A motion was made by Marcia Mullis and seconded by Matthew Brooks to appoint Tamara Reed as Council Secretary for 2021-2022. Motion passed. A motion was made by Amanda Gordon and seconded by Loretta Parnell to dispense with the reading of the minutes and approve as presented in the packet. Motion passed. Pastor Adam Goodrich requested an addition to the agenda for Presentation of Nominees for Synod Delegates. A motion was made by Larry Gossett and seconded by Dewey Mullis to adopt the Agenda. Motion passed.

The following members were appointed to serve as Tellers: Beth Alphin (Head Teller), Brent Weavil, Vanessa Gossett, Melody Thomason, Kim Harris and Patrick Allen. Pernell Collett was appointed Parliamentarian. A motion was made by Amanda Gordon and seconded by Nancy Sawtelle to approve these appointments. Motion passed.

Matthew Brooks and Connie Buck were nominated from the floor. A motion was made by Vanessa Gossett and seconded by LeaAnn Haynes to close the nominations. Elected were: Edward Gordon, Pernell Collett, LeaAnn Haynes, Tonya Flippin, Marianne Smith and Connie Buck.

BOARD OF TRUSTEES: Nominations submitted by the Nominating Committee were: Larry Gossett*, Marty Vogler*, Debbie James, Carson Marsh and Kevin Brinegar*. Adam Logan was nominated from the floor. A motion was made by Vanessa Gossett and seconded by Robert Alphin to close the nominations. A motion was made by Beth Alphin and seconded by Vanessa Gossett to elect those nominees by acclamation. Elected by acclamation were: Larry Gossett*, Marty Vogler*, Debbie James, Carson Marsh, Kevin Brinegar* and Adam Logan.

GRAVEYARD COMMITTEE: Nominations submitted by the Nominating Committee were: Larry Gossett*, Betsy Caviness, Chuck Sapp*, Paige Lanier and Adam Logan. There were no nominations from the floor. A motion was made by Tracey James and seconded by Vanessa Gossett to close the nominations. Elected were: Larry Gossett*, Betsy Caviness, Chuck Sapp and Paige Lanier.

YOUTH REPRESENTATIVE TO THE BOARD OF TRUSTEES AND BOARD OF ELDERS: Nominations submitted by Youth Council for Board of Trustees was Hannah Brooks and Riley Logan for Board of Elders. There were no nominations from the floor for either election. A motion was made by Marcia Mullis and seconded by Dewey Mullis to close the nominations. A motion was made by Robert Alphin

and seconded by Vanessa Gossett to elect **Riley Logan** by acclamation to the Board of Elders. A motion was made by Amanda Gordon and seconded by Vanessa Gossett to close the nominations. A motion was made by Larry Gossett and seconded by Emily Brooks to elect **Hannah Brooks** by acclamation to the Board of Trustees.

SYNOD 2022 REPRESENTATIVES AND ALTERNATES: Those nominated were: Sarah Brent, Heather Allen, Pernell Collett and Amy Logan. Nominated from the floor were Nancy Sawtelle and Dewey Mullis. A motion was made by Bill Hickman and seconded by Sherri Bogue that those nominees receiving the three (3) highest votes be elected as representatives and those remaining would be alternates and their names would be listed in order, according to total votes received. Motion passed. A motion was made by Beth Alphin and seconded by Adam Logan to close the nominations. Elected as representatives were: Sarah Brent, Heather Allen and Pernell Collett. Alternates are in order of votes received: Amy Logan, Nancy Sawtelle and Dewey Mullis.

Larry Gossett, Chairman of the Board of Trustees presented the proposed budget for 2022 totaling \$421,676. Questions were encouraged, asked and answered. Following discussion, a motion was made by Carrene Sink and seconded by Matthew Brooks to approve the budget. Discussion followed and Sarah Brent stated Call for Question. A total of 66 ballots were cast. 57 for and 9 against.

Other/New Business Items

Pastor Adam indicated there were more Ushers needed for Sunday morning worship service. Anyone interested should see him following Council.

Robert Alphin thanked those who helped carry our congregation during the pandemic. Those recognized by Robert included: Our Pastors, Adam Goodrich and John Rights, Stephanie Goodrich, Tommy Reed, Kevin Brinegar, Nancy Sawtelle, Elsa Heckman, the Band and the Choir.

Joan Charles asked we pray for Larry Jarvis.

Marcia Mullis thanked Kevin Brinegar and Tommy Reed for their assistance with the video ministry and expressed her wish that this ministry continue for those who are limited to on-line worship. However, there have been issues with the equipment and perhaps steps could be taken to update or replace this equipment.

Church Council was adjourned following prayer by Pastor Rights and the singing of "Christian Hearts in Love United". Meeting officially adjourned at 2:35pm.
